 Analysis and improvement of the firearms and ammunition organizational structure regarding its national ownership, adequacy of the responsible institutions and proper allocation of resources.



SALES

Keeping track of national markets, exports and imports of firearms and ammunition.

A. EXPORTS

- Monitoring compliance with the Programme of Action to Combat the Illicit Trade in Small Arms and Light Weapons and the Arms Trade Treaty;
- Reporting cases of violation regarding national and international obligations;
- Local advocacy for adhesion and full implementation of the PoA, ATT and other legal instruments (national and international);
- Participation at international forums to universalize and implement international instruments of regulation and cooperation;

SEIZURE OF ILLEGAL ARMS AND AMMUNITION

- Research on the nature and origin of ammunition and firearms apprehended by security officials to guide preventive policies and increase arms seizures;
- Support police agencies on the improvement of processes of registration, forensic analysis and investigation to optimize the fight against the illegal market and criminal use of firearms;

CUSTODY OF INSTITUTIONAL STOCKPILES AND SEIZED FIREARMS

- Monitoring firearms and ammunition stockpiles and identification of risk-prone situations;
- Analysis and proposal of procedures to make the custody of firearms and ammunition safer, traceable and accountable.

DEMILITARIZATION AND DESTRUCTION

- Tracking of firearms and ammunition demilitarization;
- Inter-institutional coordination to rationalize the destruction of firearms from their official removal from the inventory to waste disposal.

B. DOMESTIC SALES

- Permanent improvement of national regulation on civilians access to firearms and ammunition;
- Monitoring changes in the patterns of firearms and ammunition acquired by public institutions.



- Promotion, through working groups, of cooperation between the various public institutions involved in the seizure of these materials, proposal of new procedures and joint development of continuous cooperation mechanisms;
- Strengthening national and subnational focal points for firearms tracing and response to foreign requests, including the analysis of organizational structure, development of databases, reports and procedures:
- Organization of voluntary surrender or buy-back campaigns in Brazil;
- Planning of workshops and events to increase exchanges between civil society leaders and police officers.
